RESEARCH GRANTS

- Grants for research in specific diseases are based on scientific merit and established significance of the disease in dogs.
- Grants for research on specific breeds are also based on scientific merit and significance in a particular breed as identified by the Parent Club.

 Research in specific breeds falls under the Parent Club Partnership Program, which outlines the availability of matching funds and the opportunities for Parent Clubs to open restricted funds with the AKC Canine Health Foundation.



PARENT CLUB PARTNERSHIP PROGRAM:

- The Parent Club Partnership Program is designed to provide assistance to Parent Clubs attempting to resolve serious health problems in purebred dogs. All parent clubs of breeds recognized by the American Kennel Club are eligible.
- The Parent Club Partnership Program is composed of three separate types of assistance. They may be used individually or in combination.

Assistance with identification and review of proposed research

- II. Establishment of Parent Club Funds
- III. Parent Club Matching Fund Program



DONOR ADVISED FUND:

- <u>Contributions are restricted to a specific health related</u> <u>purpose established by the donor, which may be either an</u> <u>individual or a club</u>
 - Research that will advance the health of a particular breed
 - research that will study a specific disease or group of diseases
 - Foundation seeks the advice of the donor regarding research to be supported with the restricted contribution
 - Multiple contributions accepted to the fund from clubs and individuals
 - Interest earned on contributions to funds
 - Donations are tax deductible
 - Clubs appoint a health liaison to keep the Foundation advised of current information regarding the breed and the health priorities of the parent club

BENEFITS:

Provide a registry of purebred dogs that have been certified free of heritable eye disease by American College of Veterinary Ophthalmologists (A.C.V.O.)

 Provide various reports on the prevalence of eye diseases in certain breeds

MISSION:

To provide a source of health information for owners, breeders, and scientists, that will assist in breeding healthy dogs







GOAL:

•Work with parent clubs to identify health issues for establishing breed specific central information system

•Establish and maintain breed specific central health data base that supports research of canine disease and provides health information to owners and breeders

•Establish scientifically valid diagnostic criteria for the acceptance of information into the database

 Base the availability of information on individually identified dogs at the owners consent







BENEFITS:

Reliable & accurate source of informationbreeders, buyers and owners
Secure environment maintained by an impartial 3rd party
Accurate aggregate data on multiple generations of dogs
A tool to evaluate the occurrence of a disease and monitor progress







REQUIREMENTS:

• BREED SPECIFIC AND DRIVEN BY PARENT CLUB

• DOGS MUST HAVE PERMANENT ID – TATTOO OR MICROCHIP







CHIC Numbers A CHIC number is issued when test results are entered satisfying each breed specific requirement AND when the owner has opted to release the results.







CHIC Report A CHIC Report is a consolidated listing of all tests performed, the age at the time of testing, and the corresponding results.
